

SECOND: The following amendment of the Certificate of Incorporation was adopted by the Corporation in the manner prescribed by the District of Columbia Non-Profit Act:


FIRST: The name of the corporation is the National Court Reporters Association.



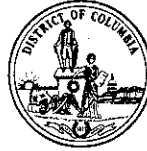



CERTIFICATE OF INCORPORATION.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are citizens of the United States and of the District of Columbia, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the provisions of Subchapter III of Chapter XVIII of an Act of Congress entitled "An act to establish a code of law for the District of Columbia, approved March 3, 1901, and amended by the Acts of Congress approved January 31, 1902 and June 30, 1902:

AND WE HEREBY CERTIFY,

FIRST. That the name of said corporation shall be the "National Shorthand Reporters' Association."

SECOND. That the term of existence of said corporation shall be perpetual from and after the date of its incorporation.

THIRD. That the particular business and objects of the said National Shorthand Reporters' Association shall be to secure the benefits resulting from organized effort, the recognition and promotion of professional ethics, to foster a scientific spirit in the profession, to secure the maintenance of a proper standard of efficiency and compensation, the enlightenment of the public as to the possibilities and limitations of shorthand, the promotion and maintenance of proper stenographic laws, and, in general, the advancement of the interests of the shorthand profession.

FOURTH. That the number of DIRECTORS who shall manage the affairs of said corporation for the first year of its existence shall be seven, and their names and addresses are as follows:
