

WHAT HAS NCRA DONE FOR CAPTIONERS TIMELINE

1979

Federal government formed a non-profit, the National Captioning Institute, charged with the mission of making closed captioning a reality.

Early 1980s

CAT Committee educated NCRA members on the possibility of captioning. Few believed 98 percent accuracy was possible to achieve in reporting anything, let alone a live news broadcast.

First realtime courtroom showcased as the Courtroom of the Future

While private organizations were working to overcome the barriers created by technology, then-NSRA was educating members on using computer-aided transcription (CAT).

1982

Joe Karlovits provide the first CART ever for deaf attorney Michael A. Chatoff, Esq., in the Board of Education v. Amy Rowley, a critically important deaf education case, before the U.S. Supreme Court.

was the first televised show to include closed captioning.

ABC World News Tonight was the first regularly scheduled program to be realtime captioned
