- NCRA will assign testing spots based on space and time limitations. Once all time slots are taken, a wait-list will be maintained. If you are wait-listed, you will be notified if and when a time slot becomes available. NCRA does not defer exam costs. Your payment will not be processed until you have been assigned a testing slot.

- Submitting your registration form before the deadline does not secure a time slot for you. Slots may fill up before the deadline. **Do NOT make travel arrangements until you receive a confirmation email with your time slot.***

* NCRA plans on conducting the CLVS Production Exam/Hands-On Training as specified. We will be monitoring all COVID-19 guidance from national, state, and local public health professionals. Our priority is the health and safety of all those participating. We plan to provide updates and anticipate making a decision whether to proceed or reschedule at approximately the beginning of October. If canceled, registration fees will be refunded in full. **Attendees/registrants are cautioned against making nonrefundable travel arrangements, since NCRA will not be responsible if the program needs to be rescheduled.**
