NOMINATION CRITERIA

1. The nominee must be an NCRA member in good standing from the following categories: Registered Member, Participating Member, Retired Registered Member, or Retired Participating Member.
2. The nominee must have demonstrated altruistic behavior – unselfish regard for or devotion to the welfare of others – in accordance with the following definition: *Altruism is a behavior by a person that is not of benefit, or may even be harmful, to himself or herself but that benefits others. Altruism is not merely helping others; believing that you have a duty to help others, not that you owe others, is altruism – self-sacrifice, not self-interest.*
3. The nominee must have been a working captioner or court reporter for at least 25 years, demonstrating career longevity and commitment.
4. All nominations will be reviewed by the Aurelio Award for Altruism Task Force. The recipient will be approved by the NCRF Board of Trustees and announced at the 2019 NCRA Convention & Expo.

NOMINATION STEPS

- Keeping the above criteria in mind, complete the information on page two and submit by June 30, 2019.
- All information requested must be provided or the nomination is invalid and will not be considered.
- You may nominate more than one person; however, you must complete a separate nomination form for each nominee.
