Local Court Reporting Student Awarded Scholarship
Lucy Wilde, from Edmonton, Alberta, Canada, awarded a \$750 scholarship

RESTON, Va., July 6, 2022 — The National Court Reporters Association (NCRA), the country’s leading organization representing stenographic court reporters, captioners, and legal videographers, has announced that Lucy Wilde, from Welling, Alberta, Canada, a student at the Northern Alberta Institute of Technology in Edmonton, has been awarded a \$750 [NCRA A to Z® Scholarship](#). The scholarships are supported by funds from the National Court Reporters Foundation (NCRF), the philanthropic arm of NCRA.

[NCRA’s A to Z® Intro to Steno Machine Shorthand](#) program, a free online six-to-eight-week introductory course, lets participants see if a career in court reporting or captioning would be a good choice for them. The program is an introductory course in stenographic theory and provides participants with the opportunity to learn the basics of writing on a steno machine. There is no charge to take the course, but participants are required to have access to a steno machine or an iPad they can use to download an [iStenoPad app](#).

Wilde is currently writing at 160 words per minute and hopes to graduate in April 2023. She plans on working as an official court reporter first and later moving into captioning.

“This scholarship will help me pay for schooling so I can save up to buy a steno machine,” she said. “My mom’s chiropractor told her that his daughter was a court reporter, and I found out a bunch of people in my hometown are also court reporters, so I did some research and was very interested,” she added about how she randomly found out about the career.

For others considering the career, Wilde advises that while the schooling might sound scary, the work you put into it won't go unnoticed. "For the job, the information you learn varies day to day, which never gets boring. The hours can also be very flexible which helps if you have kids, or you are just a busy person," she added.

Students who have completed an NCRA A to Z[®] Intro to Steno Machine Shorthand program and are enrolled in a court reporting program are encouraged to apply for consideration of one of 15 \$750 scholarship awards.

Qualified applicants must have completed the NCRA A to Z[®] Intro to Steno Machine Shorthand program as well as passed a Skills Test writing between 60 and 100 wpm, among other eligibility requirements.
