*Cindy L. Isaacsen from Shawnee, Kansas named NCRA Secretary-Treasurer*

**RESTON, Va., July 22, 2022** — The National Court Reporters Association (NCRA), the country's leading organization representing stenographic court reporters, captioners, and legal videographers, has announced that Cindy L. Isaacsen, an official court reporter from Shawnee, Kan., will serve as its 2022-2023 Secretary-Treasurer. Isaacsen is an official court reporter for the 10th Judicial District Court in Olathe, Kan. Isaacsen also worked as an official court reporter for the 36<sup>th</sup> Judicial District Court in DeRidder, La.

At the national level, she served on NCRA's Election Committee in 2016-2017, and as a regional representative, and as Vice Chair for the National Committee of State Associations (NCSA). Isaacsen has also served on various committees, including the Finance Committee, the Brand Ambassadors Council, and the Student/Teacher Committee.

At the state level, Isaacsen has served on the board and twice as president of the Kansas Court Reporters Association. She has also served as a speaker for several state associations. She is a graduate of the Stenograph Institute of Texas.
