Local Court Reporting Student Awarded Scholarship
Jemima Almanrode, from Fort Collins, Colo., awarded a \$750 scholarship

RESTON, Va., July 6, 2022 — The National Court Reporters Association (NCRA), the country’s leading organization representing stenographic court reporters, captioners, and legal videographers, has announced that Jemima Almanrode, from Fort Collins, Colo., a student at Cuyahoga Community College in Cleveland, Ohio, has been awarded a [\\$750 NCRA A to Z® Scholarship](#). The scholarships are supported by funds from the National Court Reporters Foundation (NCRF), the philanthropic arm of NCRA.

The [NCRA A to Z® Intro to Steno Machine Shorthand](#) program, a free online six-to-eight-week introductory course, lets participants see if a career in court reporting or captioning would be for them. The program is an introductory course in stenographic theory and provides participants with the opportunity to learn the basics of writing on a steno machine. There is no charge to take the course, but participants are required to have access to a steno machine or an iPad they can use to download an [iStenoPad app](#).

Almanrode, who is currently writing at a speed of 120 words per minute, hopes to graduate in the spring of 2024 and plans to pursue a career in court reporting rather than captioning.

“This scholarship will help me with my tuition as I am now able to take another class in the fall of 2023,” she said. “I heard about court reporting through the court reporters I work with at my current job as a court judicial assistant.”

Almanrode said she would highly encourage individuals who are looking for a career change to look into stenography by taking the NCRA A to Z program.

“A career as a stenographer is not only rewarding but there are so many options. You have the opportunity to work in the court system, freelance, caption from home, or assist someone with

CART (Communication Access Realtime Translation). All options are so beneficial to the public,” she added.

Students who have completed an NCRA A to Z[®] Intro to Steno Machine Shorthand program and are enrolled in a court reporting program are encouraged to apply for consideration for one of 15 \$750 scholarship awards.

Qualified applicants must have completed the NCRA A to Z[®] Intro to Steno Machine Shorthand program as well as pass a skills test writing between 60 and 100 wpm, among other eligibility requirements.
