### **Local Court Reporting Student Awarded Scholarship** *Rachel Leon, from Mission Hills, Calif., awarded a \$750 scholarship*

**RESTON, Va., July 6, 2022** — The National Court Reporters Association (NCRA), the country’s leading organization representing stenographic court reporters, captioners, and legal videographers, has announced that Rachel Leon, from Mission Hills, Calif., a student at the Downey Adult School in Downey, Calif., has been awarded a \$750 [NCRA A to Z® Scholarship](#). The scholarships are supported by funds from the National Court Reporters Foundation (NCRF), the philanthropic arm of NCRA.

The [NCRA A to Z® Intro to Steno Machine Shorthand](#) program, a free online six-to-eight-week introductory course, lets participants see if a career in court reporting or captioning would be for them. The program is an introductory course in stenographic theory and provides participants with the opportunity to learn the basics of writing on a steno machine. There is no charge to take the course, but participants are required to have access to a steno machine or an iPad they can use to download the [iStenoPad app](#).

Leon, who is writing at 120 words per minute, expects to graduate in 2024 and plans to pursue a career as an official court reporter. She said she learned about the profession from family when she was exploring careers in high school and added that the scholarship will help pay for part of her tuition.

“The court reporting profession is an amazing career to join. This career has benefits that can help you and your family thrive. It opens a whole new community of reporters who can relate to what you do, so you do not feel alone in the race to success,” Leon added.

Students who have completed an NCRA A to Z® Intro to Steno Machine Shorthand program and are enrolled in a court reporting program are encouraged to apply for consideration for one of 15 \$750 scholarship awards.

Qualified applicants must have completed the NCRA A to Z® Intro to Steno Machine Shorthand program as well as pass a Skills Test writing between 60 and 100 wpm, among other eligibility requirements.
