Local Court Reporting Student Awarded Scholarship Vennecia Lopez, from Yuma, Ariz., awarded a \$750 scholarship

RESTON, Va., July 6, 2022 — The National Court Reporters Association (NCRA), the country's leading organization representing stenographic court reporters, captioners, and legal videographers, has announced that Vennecia Lopez, from Yuma, Ariz., a student at Cuyahoga Community College in Cleveland, Ohio, has been awarded a \$750 NCRA A to Z® Scholarship. The scholarships are supported by funds from the National Court Reporters Foundation (NCRF), the philanthropic arm of NCRA.

The NCRA A to Z[®] Intro to Steno Machine Shorthand program, a free online six-to-eight-week introductory course, lets participants see if a career in court reporting or captioning would be for them. The program is an introductory course in stenographic theory and provides participants with the opportunity to learn the basics of writing on a steno machine. There is no charge to take the course, but participants are required to have access to a steno machine or an iPad they can use to download the iStenoPad app.

Lopez, who is currently writing at 90 words per minute, plans to graduate in 2024 and hopes to pursue a career as an official court reporter.

"This scholarship paid my entire summer tuition," Lopez said and added that she first heard about the court reporting profession about five years ago when she began her current job as a courtroom clerk.

"For those that want a rewarding and lucrative career in the court system, love law, and order, but dislike public speaking, court reporting is for you," she added

Students who have completed an NCRA A to Z^{\otimes} Intro to Steno Machine Shorthand program and are enrolled in a court reporting program are encouraged to apply for consideration for one of 15 \$750 scholarship awards. The NCRA A to Z^{\otimes} Scholarship program was expanded this year from awarding 10 scholarships at \$500 each to awarding 14 scholarships at \$750 each.

Qualified applicants must have completed the NCRA A to Z[®] Intro to Steno Machine Shorthand program as well as pass a skills test writing between 60 and 100 wpm, among other eligibility requirements.

traditional four-year degree. The U.S. Bureau of Labor Statistics reports that the court reporting field is expected to be one of the fastest areas of projected employment growth across all occupations. According to 247/WallSt.com, the court reporting profession ranks sixth out of 25 careers with the lowest unemployment rate, just 0.7 percent.
