Local Court Reporting Student Awarded Scholarship Jessi Norris from Medicine Hat, Alberta, Canada, awarded a \$750 scholarship

RESTON, Va., July 6, 2022 — The National Court Reporters Association (NCRA), the country's leading organization representing stenographic court reporters, captioners, and legal videographers, has announced that Jessi Norris from Medicine Hat, Alberta, Canada, a student at Northern Alberta Institute of Technology (NAIT) in Alberta, has been awarded a \$750 NCRA A to Z® Scholarship. The scholarships are supported by funds from the National Court Reporters Foundation (NCRF), the philanthropic arm of NCRA.

The NCRA A to Z^{\otimes} Intro to Steno Machine Shorthand program, a free online six-to-eight-week introductory course, lets participants see if a career in court reporting or captioning would be for them. The program is an introductory course in stenographic theory and provides participants with the opportunity to learn the basics of writing on a steno machine. There is no charge to take the course, but participants are required to have access to a steno machine or an iPad they can use to download an iStenoPad app.

Norris, who is writing at 160 words per minute, expects to graduate in the spring of 2023 and is leaning toward working as a court reporter rather than a captioner.

"This scholarship was such an amazing surprise, and it will help me with the cost of my software and machine rental for my second year," Norris said.

"I heard about the court reporting profession from my mother. She told me she had always thought it was an interesting career, so I spent the next few hours looking into court reporting, and the next day I applied to NAIT. I had so much fun learning to write shorthand. I think it's the coolest thing in the world," she added.

Norris said she encourages everyone she knows to investigate the career. "NAIT has an amazing captioning and court reporting program. I fully trust every one of my instructors with my education; they are amazing."

Students who have completed an NCRA A to $Z^{\mathbb{R}}$ Intro to Steno Machine Shorthand program and are enrolled in a court reporting program are encouraged to apply for consideration for one of 15 \$750 scholarship awards.

Qualified applicants must have completed the NCRA A to Z^{\otimes} Intro to Steno Machine Shorthand program as well as pass a skills test writing between 60 and 100 wpm, among other eligibility requirements.
