Local Court Reporting Student Awarded Scholarship
Cheyenne Preston, from San Diego, Calif., awarded a \$750 scholarship

RESTON, Va., July 25, 2022 — The National Court Reporters Association (NCRA), the country’s leading organization representing stenographic court reporters, captioners, and legal videographers, has announced that Cheyenne Preston, from San Diego, Calif., a student at Poway Adult School in Poway, has been awarded a \$750 [NCRA A to Z® Scholarship](#). The scholarships are supported by funds from the National Court Reporters Foundation (NCRF), philanthropic arm of NCRA.

[NCRA’s A to Z® Intro to Steno Machine Shorthand](#) program, a free online six-to-eight-week introductory course lets participants see if a career in court reporting or captioning, would be a good choice for them. The program is an introductory course in stenographic theory and provides participants with the opportunity to learn the basics of writing on a steno machine. There is no charge to take the course, but participants are required to have access to a steno machine or an iPad they can use to download an [iStenoPad app](#).

Preston, who is currently writing at 140 words per minute, anticipates graduating with in the next 10 months, and plans to begin her career as an official court reporter before moving in the world of freelance court reporting.

“I’m so honored to get this scholarship and intend to put the money towards my new professional stenographic machine. I first learned what court reporting was from my amazing aunt, Stacy. I have her to thank for how far I’ve come. She’s the one who introduced me to the A to Z program and got me started in my current course,” Preston said.

Students who have completed an NCRA A to Z® Intro to Steno Machine Shorthand program and are enrolled in a court reporting program are encouraged to apply for consideration of one of 15 \$750 scholarship awards.

Qualified applicants must have completed the NCRA A to Z® Intro to Steno Machine Shorthand program as well as pass a Skills Test writing between 60 and 100 wpm, among other eligibility requirements.
