**Local court reporter earns \$2,000 New Professional Reporter Grant**  
*Averie Pritchard of Jeannette, Pa., wins top honors*

**RESTON, Va., Aug. 8, 2024** — The National Court Reporters Foundation (NCRF), the philanthropic arm of the National Court Reporters Association (NCRA), presented the [New Professional Reporter Grant](#) in the amount of \$2,000 to Averie Pritchard, an official court reporter from Jeannette, Pa. NCRA is the country’s leading organization representing stenographic court reporters, captioners, and legal videographers. The announcement was made at a special awards luncheon at the 2024 NCRA Conference & Expo held Aug. 1-3 in Louisville, Ky.

NCRF awards the annual New Professional Reporter Grant to a reporter who is in his or her first year of work, has graduated within a year from an NCRA-approved court reporting program, and meets specific criteria, including a grade point average of 3.5 or above, a letter of recommendation, an answer to an essay question, and is actively working in any of the career paths of judicial (official/freelance), CART, or captioning.

“I am honored and excited to have been chosen to receive this grant by the NCRF Trustees,” said Pritchard, an official court report with the Court of Common Pleas Tenth Judicial District of Pennsylvania.

“I am grateful and plan to use this award to further my skills and fund my certification training and testing. Thank you so much,” she added.

Court reporters and captioners rely on the latest in technology to use stenographic machines to capture the spoken word and translate it into written text in real time. These professionals work both in and out of the courtroom recording legal cases and depositions, providing live captioning of events, and assisting members of the deaf and hard-of-hearing communities with gaining access to information, entertainment, educational opportunities, and more.
