Local court reporter to serve on national board *Shellene L. Iverson from Portland, Ore., to serve a three-year term*

RESTON, Va., July 30, 2025 — The National Court Reporters Association (NCRA), the country's leading organization representing stenographic court reporters, captioners, and legal videographers, announced that Shellene L. Iverson, RPR, a freelance court reporter and agency owner from Portland, Ore., has been appointed to serve a three-year term as Director.
