**Local court reporter earns \$4,000 New Professional Reporter Grant**  
***Delainey Dutch from Fayetteville, N.C., receives top honors***

**RESTON, Va., July 31, 2025** — The National Court Reporters Foundation (NCRF), the philanthropic arm of the National Court Reporters Association (NCRA), presented the [New Professionals Reporter Grant](#) in the amount of \$4,000 to Delainey Dutch, RPR, from Fayetteville, N.C. NCRA is the country's leading organization representing stenographic court reporters, captioners, and legal videographers. The announcement was made at a special awards luncheon at the 2025 NCRA Conference & Expo held July 24-26 in Minneapolis, Minn.

Dutch, who holds the nationally recognized professional certification of Registered Professional Reporter (RPR), is a military veteran and spouse and the mother of a toddler. She currently works as a freelance court reporter.

"I deeply appreciate being selected as this year's recipient of the New Professionals Grant," she said. "This will have a great impact on my family and helps immensely to offset all those startup costs that we all incur as we get our business going.
